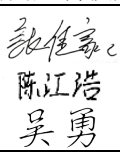

Test Procedure 测试程序:

1. Tests T.1 to T.5 are conducted in sequence on the same battery, Tests 6 and 8 are conducted using not otherwise tested batteries. Test T.7 may be conducted using undamaged batteries previously used in Tests T.1 to T.5 for purposes of testing on cycled batteries.

2. In order to quantify the mass loss, the following procedure is provided:

$$\text{Mass loss(\%)} = (M_1 - M_2) / M_1 \times 100$$

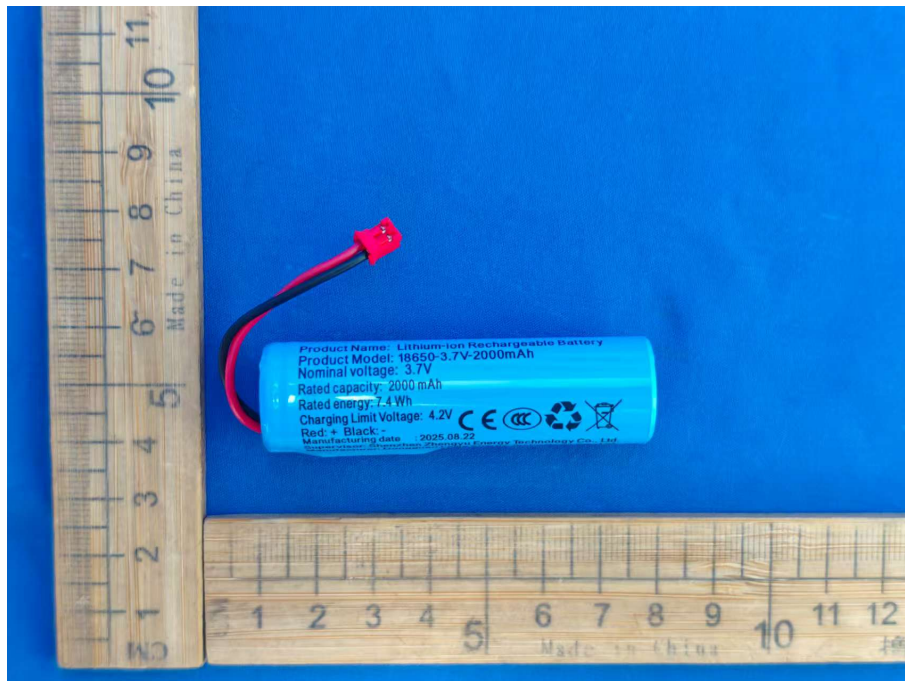


Fig. 2 – Back view of Battery

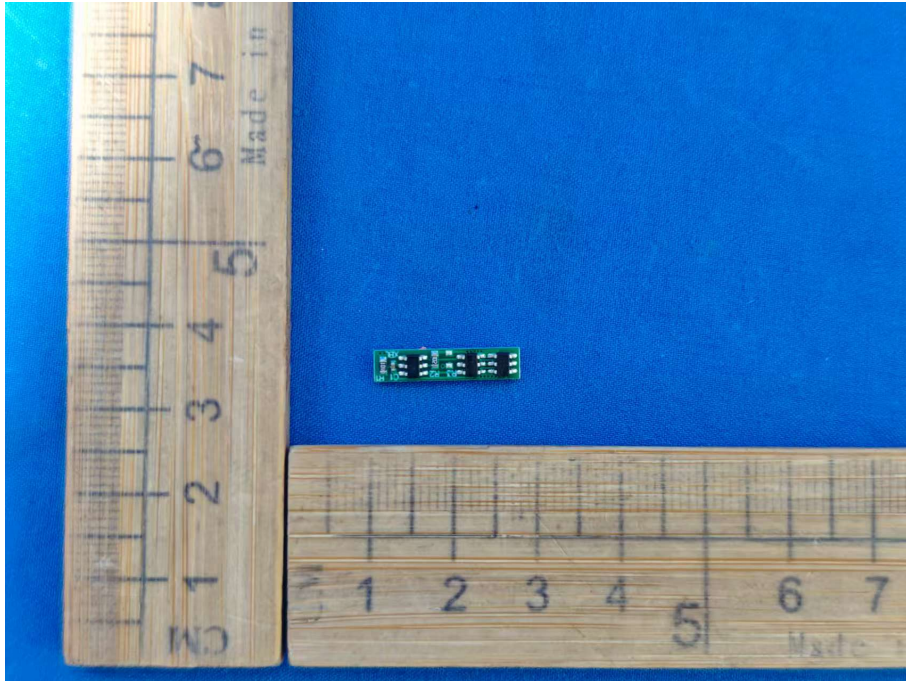
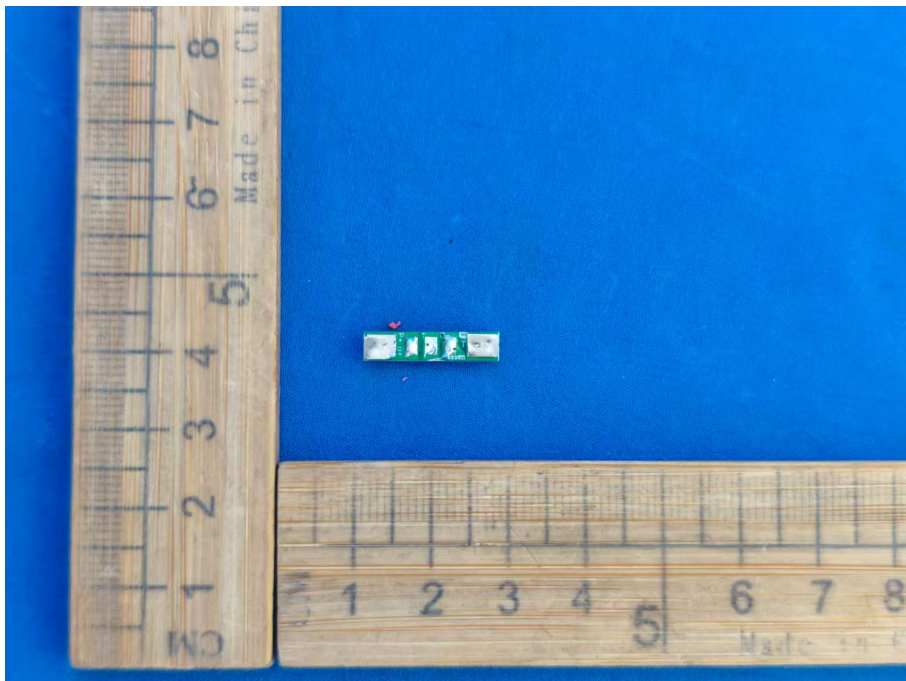


Fig. 6 – Back view of PCM
