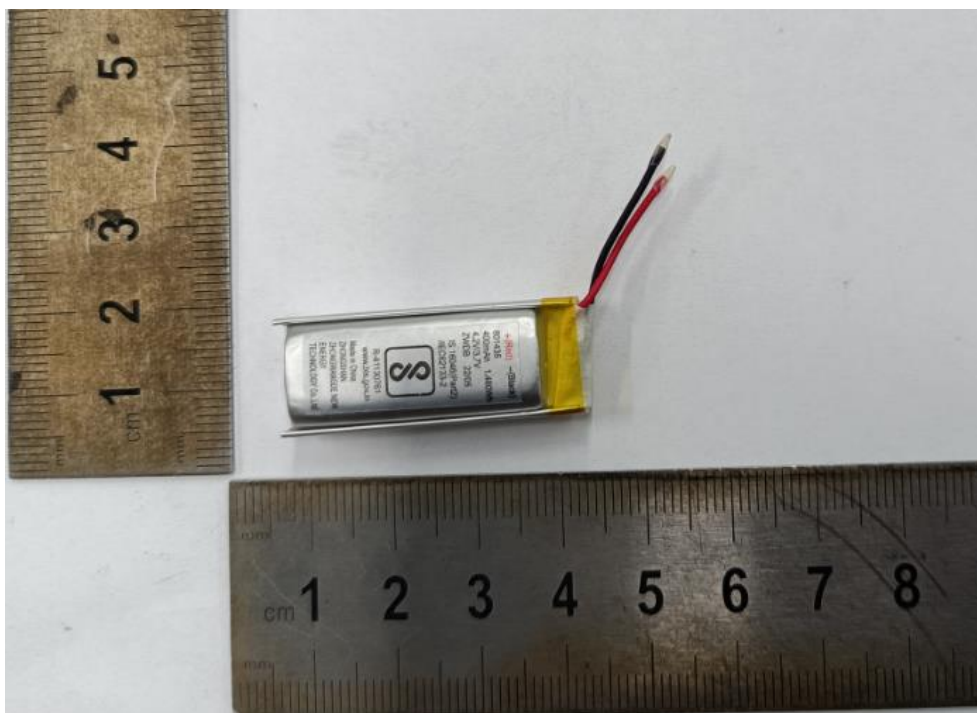


图 1 电芯正面
Picture 1 Front view of cell

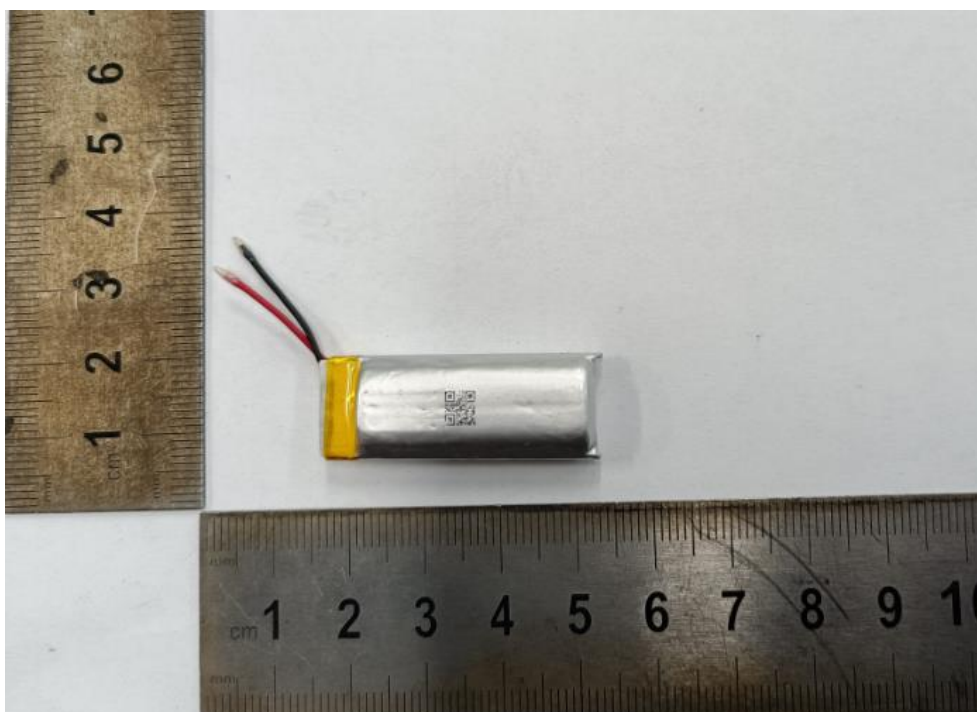


图 2 电芯反面
