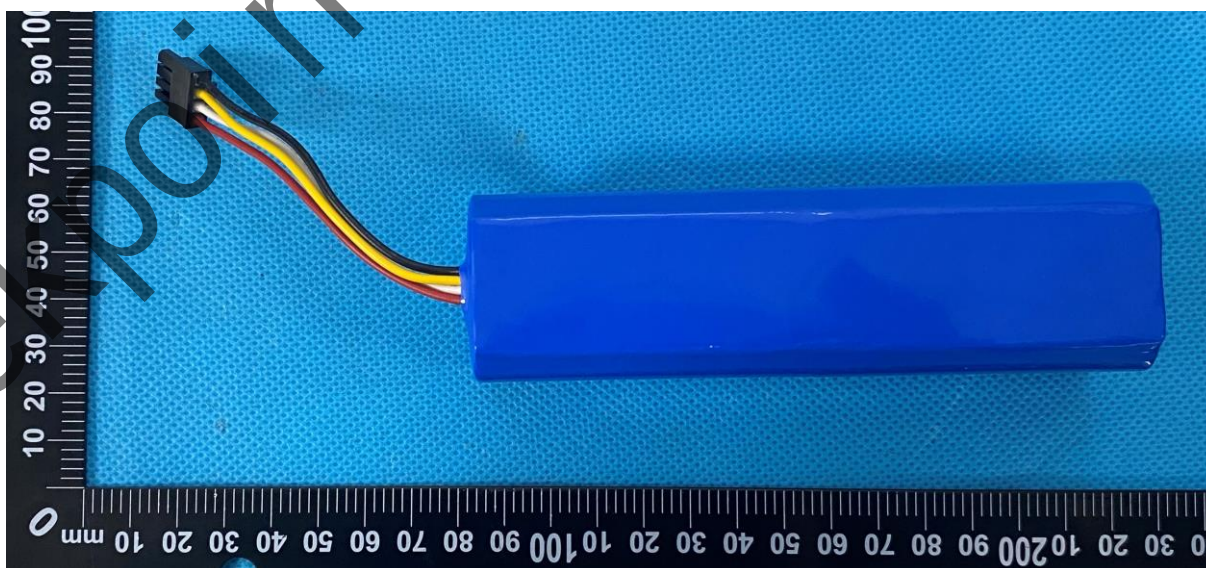

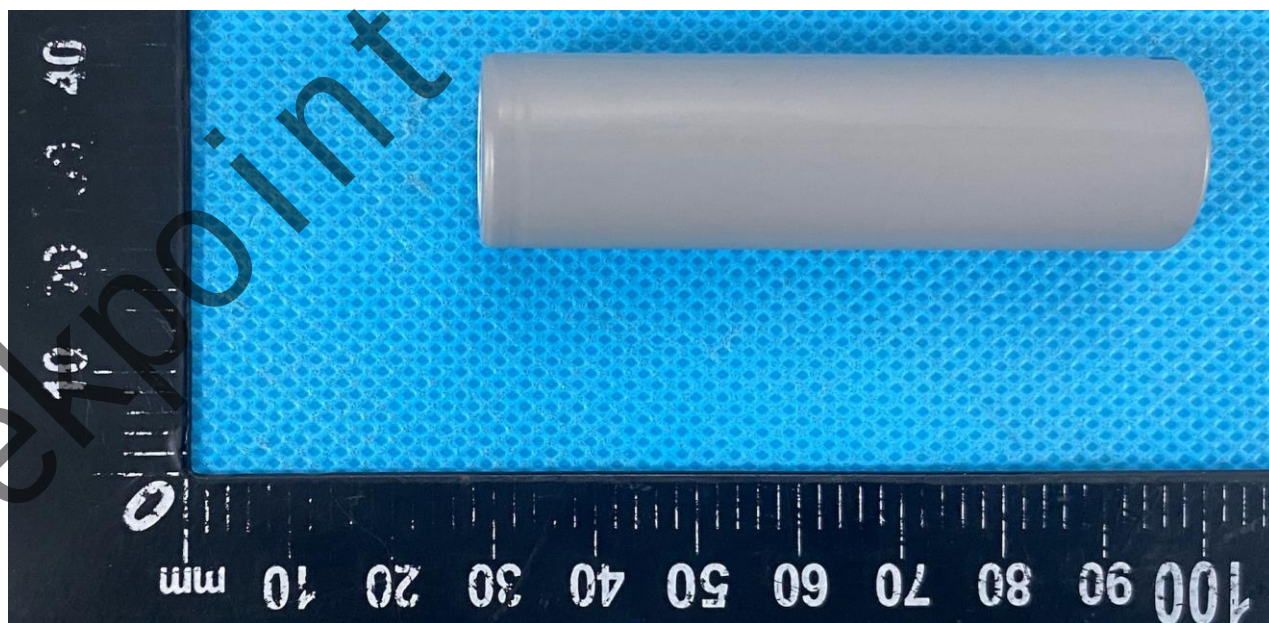
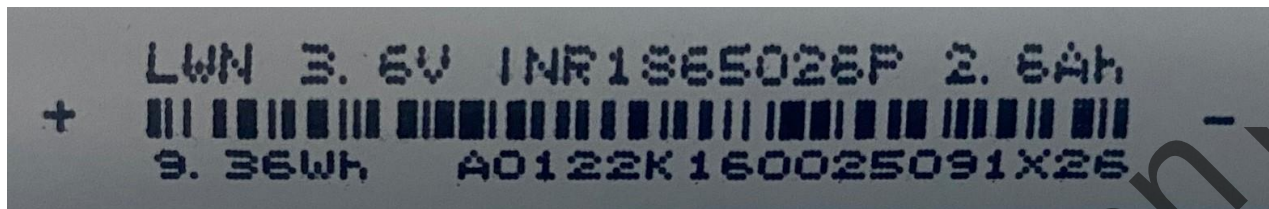

Small batteries shall be subjected to a half-sine shock of peak acceleration of 150g_n (or Acceleration(g_n)= $\sqrt{\frac{100850}{mass}}$, which is smaller) and pulse duration of 6 milliseconds, large batteries shall be subjected to a half-sine of peak acceleration of 50g_n (or Acceleration(g_n)= $\sqrt{\frac{30000}{mass}}$, which is smaller) and pulse duration of 11 milliseconds. 	The cell or battery to be tested shall be temperature stabilized so that its external case temperature reaches $57\pm4^{\circ}\text{C}$ and then the cell or battery shall be subjected to a short circuit condition with a total external resistance of less than 0.1 ohm at $57\pm4^{\circ}\text{C}$. 	☐ Crush 挤压 A cell or component cell is to be crushed between two flat surfaces. The crushing is to be gradual with a speed of approximately 1.5 cm/s at the first point of contact. The crushing is to be continued until the first of the three options below is reached. (a) The applied force reaches 13kN±0.78kN; (b) The voltage of the cell drops by at least 100 mV; or (c) The cell is deformed by 50% or more of its original thickness.
